**Defending Our Religious Liberty**

The Connecticut Catholic Conference notes that, since 1919, the Catholic Church has been a longstanding advocate of universal, accessible and life-affirming health care. However, the HHS mandate of the Affordable Care Act harshly penalizes those employers who do not provide abortions and other contraception coverage for their employees. In its decision, the Supreme Court clearly reaffirms that freedom of religion is a basic fundamental right under our Constitution. If you haven’t done so already, please voice your opposition to the mandate by calling President Obama at the White House at 202-456-1111 or U.S. Secretary of Health and Human Services Sylvia Mathews Burwell at 202-205-5445.
